PRACTICAL REQUIREMENT FOR CERTIFICATION: TSSA PRACTICAL SKILLS SIGN-OFF DOCUMENT

The Practical Skills Sign-Off Document serves as a permanent record of work performed. It is the responsibility of the student to arrange to work with a licensed petroleum mechanic to gain the necessary hours of field experience required for certification.

The sign-off document can be submitted one of two ways:

1) If the required hours have been completed, students may bring the completed document to their review & exam session -OPCA will submit on the students behalf.

 Student can submit document directly to TSSA after they have completed their course and once they have fulfilled the required hours.

Required hours for certification:

PM1 - 1000 hours PM2 - 2000 hours PM3 - 500 hours

All participants are required to purchase the TSSA Liquid Fuels Handling Code 2007 as part of their study material and can be used during the exam.
